DID YOU KNOW?

If you pass the Maryland Registered Tax Preparer Exam, you no longer have to take the Annual Federal Tax Refresher Course and Test. It is a one & done. Conversely, if you want to be an Annual Filing Season Preparer and haven't passed the Maryland Registered Tax Preparer Exam, & you're not a CPA, EA, or passed the RTRP when it was offered you must take a 6-hour annual course every year (*Here is the location to take the annual course*). As such, we recommend taking the Maryland Registered Tax Preparer Exam (*Find the exam prep course here*.)
